Environmental Molding Concepts, LLC (“EMC”) (Seller) warrants to the Buyer that the EMC tiles sold for the above named project (Tile) will be free from defects in materials and workmanship (subject to the limitations set forth below) for a period of five (5) years from the date of purchase from the Seller or its authorized dealer.

Buyer shall give Seller notice of a claim under this warranty within 30 days of discovering any defects in materials or workmanship. If Seller determines that Tile evidences defects in materials or workmanship, Seller’s liability is limited, at Seller’s option, to repair or replacement of defective Tile at the FOB point in the original contract of sale or, at Seller’s option, to a credit to Buyer not exceeding the selling price of the defective Tile. Warranty excludes installation and other costs incurred.

Seller’s responsibility for repair, replacement or credit shall be determined according to the following schedule:
